3. Quotation Price

- The contract shall be for quotation of Internet Lease line.
- The price will include all taxes and ceases.
- Goods and service tax should be shown separately.
- The rates submitted by the vendor will be fixed for the duration of **3 year**.
- The Quotation rates should be submitted in Indian Rupee.

3. Each vendor will submit a single sealed quotation. The vendor will not contact the other vendors regarding this quotation.

4. Validity of quotation

The quotation will be valid for 30 days from the date of submission of the quotation.

5. Appraisal of quotations

The buyer will compare and evaluate the quotations with the quotation response to the following matters.

- The quotations are properly signed.
- Meet the terms, conditions and criteria mentioned in the quotation.

- o Quotation should be signed, stamped & properly sealed.
- o GST rates will not be considered for assessment.
- o The bidder should submit the copy of Registration certificate (Shop Act Certificate).
- o The bidder should submit copy of GST Certificate & Pan Card
- o The bidder should submit Annual turnover certificate of min. Rs.5,00,000/-

6. Issue of Work-Order

The bidder whose bid is the most responsive (Most Appropriate quotations) bidder and whose rate is the lowest (bid) will be ordered.

A. The Buyer shall have the right to approve or reject any quotations and to cancel all quotations by canceling the process of quotations.

B. The supply order will be given to the vendor whose rates have been agreed. The terms of the agreed rate will be included in the supply order.

C. The supply pursuant to this quotation shall be valid for 1 year from the date of order.

D. Based on the satisfactory performance, the contract may extend for one year.

7. Payment mode

A. Payment of supply of Lease line is on quarterly basis, the payment will be paid within four weeks after submission of the report duly verified by Admin dept. of the PMU.

B. Before any service at PMU, the agency should get the prior approval from Admin dept of the PMU.
